WHEREAS, the California Department of Public Health ("CDPH") has made Future of Public Health ("FoPH") funds available to Local Health Jurisdictions ("LHJs"), which were originally awarded under the California Budget Act of 2022 (Health and Safety Code 101320-101320.5); and

WHEREAS, CDPH has allocated \$699,175 of Fiscal Year ("FY") 2026-27 FoPH funds to Yuba County for the term of July 1, 2026 through June 30, 2027; and

WHEREAS, it is in the best interest of the residents of Yuba County to accept and utilize the allocated funds to further develop and strengthen the public health workforce and infrastructure.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the Health and Human Services Department ("HHSD") Director is authorized to submit the required documents to CDPH for Yuba County's FY 2026-27 FoPH funding and any subsequent funds allocated.

BE IT FURTHER RESOLVED by the by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the FoPH funding and the resultant allocations for the term of July 1, 2026 through June 30, 2027 including subsequently extended term; execute amendments developed under the FoPH funding, including but

not limited to amendments for additional or lesser funding; and accept, transfer and administer all FoPH funding and any subsequent funds allocated for the stated period.

A copy of said agreements or any amendments thereto shall be filed in the office of the Clerk of the Board.
