WHEREAS, the State of California – Office of Traffic Safety has made grant funds available to provide pedestrian and bicycle safety related activities to reduce the number of persons killed and injured in accidents involving pedestrians and bicyclists; and

WHEREAS, it is in the best interest of the residents of the County of Yuba to receive pedestrian and bicycle safety education classes, bicycle helmet inspections, safety equipment, and other related resources as a result of receiving and utilizing these funds; and

WHEREAS, Yuba County Health and Human Services Department (HHSD) has applied for and seeks to be awarded grant funds in the amount of \$85,910.41 for the period of October 1, 2026 through September 30, 2027; and

WHEREAS, it is in the interest of efficient and effective county government to have a Resolution of the Board of Supervisors authorizing the HHSD Director to apply for the Pedestrian and Bicycle Safety Program grant and to execute all documents required by the application; and

WHEREAS, it is also in the interest of efficient and effective county government, in the event that the Pedestrian and Bicycle Safety Program grant funds are awarded to the County of Yuba, to have a Resolution authorizing the HHSD Director to accept, transfer and administer any grant funds received in accordance with the terms of the Pedestrian and Bicycle Safety Program.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to submit an application for the Pedestrian and Bicycle Safety Program grant and to execute all documents required by the application.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: enter into agreement with the State of California – Office of Traffic Safety for the Pedestrian and Bicycle Safety Program grant for the period of October 1, 2026 through September 30, 2027; execute, subject to review and approval of County Counsel, all documents as required by the grant for the stated period; execute amendments, including but not limited to amendments for additional or lesser funding; and accept, transfer and administer the grant funds and any subsequent funds awarded for the stated period.

A copy of the fully executed agreement or any amendment thereto shall be filed in the office of the Clerk of the Board, County of Yuba.

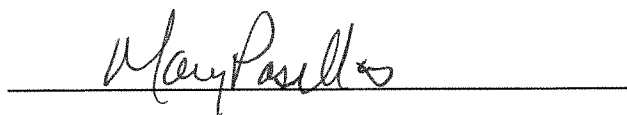
