RESOLUTION NO. 2026-62

WHEREAS, the County of Yuba Board of Supervisors has previously authorized its Chairman to execute contracts and amendments thereto, between the County of Yuba (the County) and the California Department of Forestry and Fire Protection (Cal Fire); and

WHEREAS, the County entered into a Memorandum of Understanding with the Camptonville Community Services District, Dobbins-Oregon House Fire Protection District, Foothill Fire Protection District, Loma Rica – Browns Valley Community Service District, and Smartsville Fire Protection District (Foothill Fire Districts), Authorizing the County to contract with Cal Fire for fire dispatch services on their behalf; and

WHEREAS, Cal Fire is currently providing ongoing fire dispatch services to the Foothill Fire Districts pursuant to a previously adopted Board resolution and executed Cooperative Fire Protection Reimbursement Agreement (Agreement) between the County and Cal Fire; and

WHEREAS, Cal Fire has submitted a renewal of the Agreement to the County, which constitutes a three-year agreement between the County and Cal Fire to continue fire dispatch services from July 1, 2026 to June 30, 2029, at a fee not to exceed \$326,854.

NOW, THEREFORE, BE IT RESOLVED, the Chairman of the Yuba County Board of Supervisors hereby authorized to execute on behalf of the County of Yuba the Cooperative Fire Protection Reimbursement Agreement with the California Department of Forestry and Fire Protection for fiscal years 2026/2027 through 2028/2029, and any amendments thereto, subject to approval by County Counsel.

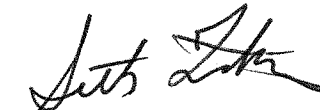

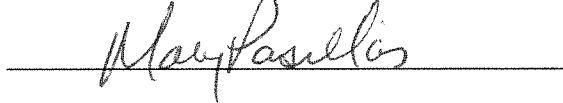

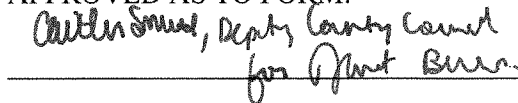
