Applications for two or more zoning and/or land division entitlements (for example: Conditional Use Permit and Design Review Permit for a shopping center) will be charged 100% of the highest application fee and may receive a 50% reduction in the Planning Department fee for each additional Planning application when submitted at the same time for a single project site (excludes miscellaneous fees/clearances, final maps, lot line adjustments, Certificates of Compliance and similar applications). Applications that may receive a fee reduction for concurrent processing are listed below with the adjusted initial application fee.

4 You must pay the Department of Fish & Wildlife fee that is in place at the time of filing your Notice of Determination												
5 You must submit an additional \$180 per map sheet exceeding 2 sheets to the Public Works Department as part of your final map project review.												
6 BUILDING PERMIT REVIEW FEES: Planning Department review fees associated with a building permit are collected by the Building Department (see County Fee Schedule Section 13.20.300 of the Yuba County Code for fees).												
7 There is a \$35 Returned Payment Fee for any returned checks.
