Session to receive public comment on the Partially Recirculated Draft Environmental Impact Report (EIR) for the Waldo Road over Dry Creek Bridge Replacement Project. The original EIR was published in March 2025. Beale Air Force Base responded to the published EIR with a letter that identified new biological information regarding fish presence in Dry Creek. As a result, the Biological Resources, Tribal Cultural Resources, and Mandatory Findings of Significance chapters of the EIR were revised and recirculated for public comment.
